**Guidelines**

**Description of the 37th Annual Scientific Sessions:**

The Eastern Nursing Research Society (ENRS) is pleased to accept abstracts to be considered for presentation at the ENRS 37th Annual Scientific Sessions entitled, *Collaborative partnerships in nursing research for the health and well-being of individuals, families, communities and populations*.

This year's theme is: **Freedom to advance health and well-being through revolutionary nursing research partnerships**

The 37th Annual Scientific Sessions appeal to all individuals interested in advancing nursing science, including nurse researchers, leaders in evidence-based practice, and dedicated nursing science students and faculty.

**Conference Objectives:**

- Describe interprofessional and collaborative programs of nursing research that address health inequities and reduce disease burden across the lifespan.
- Identify effective team-based nursing research approaches that leverage the innovative use of technologies to advance health and well-being.
- Examine strategic research training and educational partnerships for nurses to address health and wellness across clinical, community, educational, and policy settings.

**General Information:**

*This abstract is intended for individuals who are employed primarily in clinical settings or community-based organizations.*

*ENRS is offering clinical or community-based organizations the opportunity to select a clinical nurse researcher/scholar and lead author(s) from their organization to share emerging research/scholarship by presenting a poster at the 37<sup>th</sup> Annual Scientific Sessions.*

- *Clinical and community-based organizations are invited to select one clinical nurse researcher/scholar poster abstract for submission using the guidelines specified below.*
- *The lead author clinical nurse should be engaged in their research/scholarship trajectory and may be prepared at any educational degree level, including post-doctoral fellows.*
- ***Please note:*** *It is the responsibility of each clinical or community-based organization to select the poster abstract, not the clinical nurse researcher/scholar. Once selected by their clinical or community-based organization, the lead clinical nurse researcher/scholar author should submit their abstract in the online system.*
- ***There is no fee for submitting these abstracts.***

*ENRS Membership: The lead authors of all clinical or community-based organizations selected clinical nurse researcher/scholar poster presentations must be members of ENRS. Contributing authors/presenters are encouraged, but not required to be ENRS members. Online and downloadable ENRS membership applications are available at <http://www.enrs-go.org> and must be submitted and accepted prior to the abstract submission deadline.*

*All presenters are required to be paid registrants for the day of the conference on which they present. However, we do encourage presenters to register for the full ENRS Conference.*

**Abstract Layout:**

*Presentation Type: Clinical or community-based organization selected clinical nurse researcher/scholar poster presentations will be 'Poster' only.*

*Clinical or community-based organization selected clinical nurse researcher/scholars are welcome to submit their poster to the general peer-reviewed submission, but if accepted are only invited to present in one session, i.e., the clinical or community-based organization selected clinical nurse researcher/scholar poster OR peer-reviewed poster session.*

**Research Status:** *The abstract submission will be classified as either “completed research” or “ongoing research” for each Clinical Nurse Researcher/Scholar poster.*

**Research Format:** *The content of each abstract must be organized under separate headings, according to one of the research formats listed below.*

*The **Quantitative** format should be used if you are unsure of the format.*

**Systematic/Integrative/Scoping Review** research format should include:

- *Methods (Literature Search Strategy and Inclusion Criteria, Literature Review and Analysis)*
- *Concept Analysis*
- *Results*
- *Conclusions & Implications*

**Translational** research format should include:

- *Theoretical Framework (if applicable)*

- *Methods (Design, Participants, Setting, Data Collection, Analytical Approach)*

**Abstract Length:** *Abstracts must not exceed 2,500 characters. Abstracts must not exceed 2,500 characters, including spaces, (approximately 300 words).*

**Keywords:** *Keywords will be used to further define the intended audience. Select your keyword(s) carefully as this is how your abstract will be grouped for presentation. Please select the major focus of your project as your primary keyword. If you are choosing a methods keyword as your primary focus, your abstract should be about developing/refining a research method.*

5. *The analysis and/or interpretation of the findings/ results are appropriate and are presented in an organized and clear manner. The discussion reflects critical thinking and presents a nuanced understanding of the scientific implications and limitations of the results*
6. *The conclusions provide a succinct summary of the major components of the project. The implications/findings are contextualized for their impact on nursing research, education, policy and/or practice*
7. *Specific areas of future research are identified*

8. *The poster is visually appealing (limited clutter, good use of color contrast)*
9. *Effective use of figures, tables or graphics to enhance communication of results*

*0 =absent*

*1 =present but poorly articulated*

*2 =present and moderately articulated*

*3 = present and clearly articulated*

*4 = present and well articulated*
