Guidelines

Description of the 37th Annual Scientific Sessions:

The Eastern Nursing Research Society (ENRS) is pleased to accept abstracts to be considered for presentation at the ENRS 37th Annual Scientific Sessions entitled, *Collaborative partnerships in nursing research for the health and well-being of individuals, families, communities and populations*.

This year's theme is: **Freedom to advance health and well-being through revolutionary nursing research partnerships**

The 37th Annual Scientific Sessions appeal to all individuals interested in advancing nursing science, including nurse researchers, leaders in evidence-based practice, and dedicated nursing science students and faculty.

Conference Objectives:

- Describe interprofessional and collaborative programs of nursing research that address health inequities and reduce disease burden across the lifespan.
- Identify effective team-based nursing research approaches that leverage the innovative use of technologies to advance health and well-being.
- Examine strategic research training and educational partnerships for nurses to address health and wellness across clinical, community, educational, and policy settings.

General Information:

An abstract submission fee will be due for all abstract submissions. The fee can be charged to your credit card, debit card, or Authorize.Net account as part of the submission process.

The submission fee schedule is:

- Abstracts submitted by Thursday, October 3, 2024 – \$20.00 US
- Abstracts submitted after 11:59 PM Eastern time on Thursday, October 3, 2024 – \$30.00 US
- Abstract submission deadline is Wednesday, November 6, 2024, at 11:59 PM EST

The abstract submission fee helps defray the rising costs associated with our Annual Scientific Sessions.

The fee is non-refundable, regardless of acceptance.

Research Status: Each abstract submission will be classified as either “completed research” or “ongoing research”. Please select the appropriate research status for your project based on the guidelines below:

1. Abstracts representing completed research will be reviewed for paper, panel or poster presentation.
2. Abstracts representing ongoing research will be reviewed for poster presentation only.
3. Abstracts representing a systematic, scoping or integrative review and will be reviewed for poster presentation only.

ENRS Membership: The lead authors of all paper and poster presentations must be members of ENRS. Contributing authors/presenters are encouraged, but not required to be ENRS members. Online and downloadable ENRS membership applications are available at <http://www.enrs-go.org> and must be submitted and accepted prior to the abstract submission deadline.

All presenters are required to be paid registrants of the ENRS Conference.

Abstract Layout

Presentation Type: Presentations can either be ‘Paper’, ‘Poster’ or ‘Paper or Poster’.

Poster Types: Please note there will be a separate submission window for the individual school selected student posters in the following categories: BS, MS, DNP and, Early PhD. *Students are welcome to*

submit their poster to the general peer-reviewed submission, but if accepted are only invited to present in one session, i.e., the school-selected poster OR peer-reviewed poster session.

Research Format: The content of each abstract must be organized under separate headings, according to one of the research formats listed below.

All submissions will be considered for their potential contribution to the field (with the exception of the individual school selected BS, MS, DNP and Early PhD Posters). Since results may be incomplete for ongoing research in poster presentation form, authors are encouraged to describe the specific elements to be examined and their importance to nursing science. All abstracts must be received electronically no later than the deadline.

The **Quantitative** format should be used if you are unsure of the format.

Qualitative research format should include:

- Results
- Conclusions & Implications

Mixed Method research format should include:

- Theoretical Framework (if applicable)
- Background
- Purpose
- Methods (Design, Participants, Setting, Data Collection, Analytical Approach)
- Results
- Conclusions & Implications

Systematic/Integrative/Scoping Review research format should include:

- Theoretical Framework (if applicable)
- Background/Purpose
- Purpose
- Methods (Literature Search Strategy and Inclusion Criteria, Literature Review and Analysis)
- Concept Analysis
- Results
- Conclusions & Implications

Translational research format should include:

- Theoretical Framework (if applicable)
- Background
- Purpose
- Methods (Design, Participants, Setting, Data Collection, Analytical Approach)
- Results
- Conclusions & Implications

Abstract Length: Abstracts must not exceed 2,500 characters, including spaces, (approximately 300 words). Sessionboard will allow for 500 Characters for the Background and up to 1000 for each the Method, Results, Conclusions sections but overall characters should not exceed 2500 characters)

Keywords: Keywords will be used to further define the intended audience. Select your keyword(s) carefully as this is how your abstract will be grouped for presentation. Please select the major focus of your project as your primary keyword. If you are choosing a methods keyword as your primary focus, your abstract should be about developing/ refining a research method.

Acceptance and Notification:

Review Decision: An acceptance letter will be sent by email to the Lead Author in **mid-December** and must confirm their participation by early **January of 2025**. Please note that only the latest version of the submitted abstract, as of the submission deadline date, will be reviewed.

Lead Author Contacts: Lead Author Contacts may contact the office after **December 19, 2024** if they have not received notification. To protect the integrity of the review process, ENRS cannot release status information to contributing authors or other third parties.

Registration: All presenters are required to be paid registrants for the day of the conference on which they present. We do, however, encourage presenters to register for the full ENRS Conference.
